INSTRUCTIONS FOR USE

WHEN TO APPLY Best results are obtained when applied on a warm damp evening when slugs & snails are likely to appear.

For application method see side of pack.

ERAZA® pellets eventually break down naturally in the soil. For best results it is advisable NOT to apply just before rain is expected.

WHERE TO USE Use on bare soil and around edible and non-edible plants (protected and outdoors). When applying the product near food crops care should be taken to avoid pellets becoming trapped or resting in leaves.
